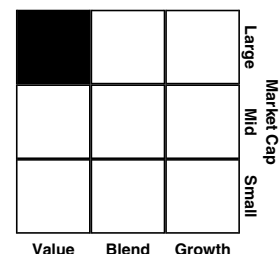


# DFA US Large Cap Value Portfolio (I)

The Fund normally invests primarily in its corresponding master fund, the U.S. Large Cap Value Series of the DFA Investment Trust Company, which has the same investment objective and policies as the U.S. Large Cap Value Portfolio. As a non-fundamental policy, under normal circumstances, the U.S. Large Cap Value Series will invest primarily in securities of large cap U.S. companies.
