
# Fidelity Adv. Growth Opportunities Fund (C)

The Fund seeks capital growth. The Fund normally invests primarily in common stocks. It invests in companies that the advisor believes have above-average growth potential (stocks of these companies are often called 'growth' stocks). The Fund invests in domestic and foreign issuers. The advisor uses fundamental analysis of factors such as each issuer's financial condition and industry position, as well as market and economic conditions to select investments.
